**Spouse/Child of a Veteran of the U.S. Armed Forces**

**I am the spouse or child of a veteran or service member of the United States Armed Forces using educational benefits under the Post-9/11 GI Bill (38 U.S.C. § 3311(b)(9) or 3319) or U.S. Code Ch. 35 and living in Maryland.**

- Copy of your Certificate of Eligibility
- Copy of your deed, lease agreement, or verification of MD address listed on student account

**38 U.S. Code § 3102 (a)**
